Greetings,

I would like to make the following comments.

Issue 2. Agreed and there should be a difference in the severity and type of emission when fines are levied, and these fines should be substantial enough to require the company to fix the problems.

Agree on the requirement that TCEQ should consider all violations when classifying an entity as a repeat violator BUT at some point, the fines should increase exponentially according to the repeat and type of violation.

Issue 5. There should be declarations of financial disclosures from each member AND concerning their immediate family for their decisions on each of permits, issues at the meetings. a wife or husband may be directly/indirectly influenced by the spouse and his/her family's financial condition.

There should be a cumulative impact study required for all new entities when a new area of industrialization is occurring as in the Brownsville Navigation District (BND), where 2 new LNG export terminals are proposed along with the current SpaceX. BND is the last of the green fields in Texas, and many local residents are in opposition to these fossil fuel and space exploration corporations which will spew their harmful emissions with an added explosion danger.

What happens when a Space X rocket falls on the LNG export terminals or one of its super heavy tankers?
